## Product Description:

AmDrop™ is an amniotic liquid allograft derived from the amniotic components of the placenta to advance soft tissue repair, replacement and reconstruction. It is classified as minimally manipulated under FDA Regulation 21 CFR part 1271 and section 361 of the PHS.

## Donor/Tissue Screening

AmDrop™ is donated human tissue and is deemed free from risk factors for and the clinical evidence of infection due to relevant communicable diseases and other exclusionary disease conditions through the review of the donor’s medical records, including medical/behavior risk assessment and a recent physical examination.

The donor is deemed eligible for tissue donation by the tissue bank’s Medical Director and has been determined to be acceptable for transplantation use through a stringent quality assurance review process. Additionally, testing of a qualified blood samples indicates that the donor is negative or nonreactive for the following communicable diseases:
